MISC -

- In June concerns that the right front door was not locking in the open position correctly. It was brought up again and I had Gordon and Backus come out and look at it. The door is fine, the paddle lock is functioning correctly.
- Illinois Local Library Act HB1910 "Opioid Antagonist Amendment" is waiting on Governor Pritzker's desk. It requires all libraries to have Narcan available and have at least one staff member trained to administer Narcan on duty during all open hours. As written it impacts Local libraries only, not Library Districts. We are waiting to hear of any change.
