**FOR THE FISCAL YEAR BEGINNING JULY 1, 2025 TO JUNE 30, 2026**

**WHEREAS**, applicable statutes authorize the Board of Library Trustees to levy taxes for library purposes.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Library Trustees of the Morris Area Public Library District, Grundy County, Illinois, as follows:

**Section 1:** Ordinance No. 25-0711 (Budget and Appropriation Ordinance) previously passed by the Board is incorporated by reference.

**Section 2:** A tax in the sum of \$1,206,703.00 is levied upon all taxable property within the District, said tax levied to defray expenses and liabilities of the District for the fiscal year beginning July 1, 2025 ending June 30, 2026 for the specific objects and purposes indicated as follows:

**Section 3:** The Secretary is authorized and directed to file a certified copy of this Ordinance with the County Clerk of Grundy County within the time specified by law.


**Section 4:** This Ordinance is in full force and effect from and after its passage.
